General Comments

Upon arriving at the facility, the children were finishing their lunch. The educator was observed sweeping the floor and sanitizing the tables as the children were finishing their lunches. Inclusion support workers were observed sitting at the lunch tables and supervising the children as they ate.

The indoor environment was clean and the parent information board was complete with all of the necessary information. The children's personal belonging were properly stored in their labelled cubbies. Daily attendance was taken, and the fire drill records were maintained. Posted on the walls were pictures of the children engaging in activities. Six child profiles were verified, and one had an expired Medicare card number. Please work with the parents to ensure that up to date Medicare numbers are posted on the child's profile.

After the children finished eating, they engaged in various free play activities such as playing with LEGOS, building blocks, k'nex pieces, dramatic play kitchen and puzzles. The educator was observed engaging and supervising with each group of children and their activities. As the children played, the educator encouraged the children to respect the material and not hit tables or throw toys across the gym. When a child threw material across the gym, the educator gently reminded the child to be respectful of all materials and to pick up the material that they threw.

One educator prepared a planned activity and asked the group who would like to participate. Some children chose to engage in the arts and craft activity while other decided to continue in the free play activities. The educator demonstrated the arts and craft "octopus" to the children and when asked, guided the children on how to create one. After completing the craft, some children engaged in dramatic play with the octopus' craft.

While playing with sport equipment, one child fell and began crying. An educator immediately ran over to console the child and ask them if they were ok. The educator was observed picking up the child and ask them if they were hurt and if so where. The educator brought the child to the "cozy corner" and sat with the child on the sofa until the child returned to play. One educator set out some play dough invitations for the children and sat down at the table. Some children chose to play with the play dough while others chose to continue their activities.
