General Comments

Upon arrival of licensing staff, the children were getting settled at the table for snack. The operator had their water bottles out and available. The operator was observed engaging in conversation with the children and sitting with them. After snack, the children engaged in free play. Some were looking out the big window for squirrels, and some played with trucks. The operator was heard giving reminders to use gentle hands and would explain how it made the other child feel. The operator changed diapers before getting ready to go outside. The operator helped the children get their snowsuits on. The children transitioned outside, and the operator did a headcount. While outside, the children played with truck and explored the backyard. The children and the operator went looking for pinecones. Some children played with a ride-on plane, and others made "food" in the kitchen. The operator was engaging in their imaginary play and eating the food. Some children got butterfly catchers out and started looking for things to catch.

It was almost lunch time, so the operator and the children transitioned inside. They got their snowsuits off and engaged in free play. The children played with trucks, the kitchen, and magnets. One child made a train with the magnets and was driving it around the room. A child gave magnets to another child and the operator was heard praising and saying "good sharing". The children and operator sang the clean up song as they picked up their toys before lunch. The children washed their hands and sat at the table for lunch. The operator helped the children and sat with them. After lunch, the operator changed diapers before nap.

The indoor environment was clean. Resources are accessible to the children on low, open shelves. Various materials are available such as, trucks, blocks, magnets, board-puzzles, animals, costumes, books, and a sensory bin. The walls are decorated with pictures of the children, their artwork, as well as learning stories with ties to the curriculum. The parent information board is up to date and only positive child guidance was observed. Licensing staff explained to the operator that tires outside should have holes or be filled with sand to prevent water accumulation.
