## **General Comments**

A Monitoring Inspection occurred on April 9, 2025.

During the visit, children were observed engaging in indoor free play and enjoying snack time. Proper handwashing procedures were followed before snack.

Educators shared that the children are currently showing strong interest in activities such as climbing the wall, being active outdoors, participating in LEGO challenges, inventing new games collaboratively, and planting flowers as gifts for Mother's Day. Educators were observed using positive language and offering gentle reminders to guide behavior, contributing to a nurturing and supportive environment.

The daily incident log is consistently maintained, and parents of children enrolled in the center are granted entry at any time. Outdoor play is part of the daily routine, and monthly emergency evacuations are conducted and posted as required. The license, along with current inspection and monitoring reports and any orders for compliance, are displayed in a clearly visible and prominent location. Evacuation procedures are also posted in an accessible area.

The facility offers a varied selection of age-appropriate equipment, materials, books, and toys. Learning and play areas are well-defined, and several examples of children's artwork are proudly displayed throughout the space, reflecting the children's involvement and creativity.

Traffic areas, both indoors and outdoors, are maintained in a clean and clutter-free condition. Toxic products, including chemical cleaners, are securely stored and inaccessible to children. Drinking water is available throughout the day.

The environment supports both individual and group experiences, offering children a variety of ways to engage. Multiple forms of literacy are embedded throughout the indoor environment, enhancing language development and communication skills.

A conversation with the Administrator took place regarding the First Aid Kits. It was discussed that the updated
