General Comments

Upon the licensing staff's arrival, the group of 2-year-olds were in the outdoor play space. The children were engaging in free play activities such as tag, balance beam and the mini cart slide. Music was heard in the background while the children were playing. The educators were observed playing tag and helping children cross the balance beam. One educator in the infant age group was observed explaining what chalk is to a group of children and began drawing on the pavement.

Attendance records were complete, children's water bottle were properly labelled, and the first aid kit was outside with the educators. The fire drill records indicate a fire drill was done in April. Child and staff records were checked and were complete. The educators were in touch with the children's needs at all times. Educators were observed wiping children's noses and offering to clean off dirty mittens.

The indoor environment was neat and well organized. The infant washroom was clean and the diaper changing procedure was posted near the changing table. The infants were observed eating their morning snack with an educator seated at the table. The educator was observed encouraging children to drink from their own water bottle and sit on their chairs while eating. The older children came inside and took off their boots and jackets and stored them in their properly labeled areas. The children engaged in free play activities such as playing in the ball pit, playing with the water table, and playing with wooden trains and train tracks.

Proper diaper changing was observed and hand washing occurred right after the diaper changing. All children washed their hands before snack and then gathered their lunch boxes and sat down at the table. The educator was observed opening snacks for the children before sitting down at the table with the children. After snack time, the children were observed dancing and playing in the ball pit with the educators. Some children decided to engage in free play activities independently. The children washed their hands before having lunch and the educators sat with the children while they ate. During this time, one educator prepared the rest areas for the children. After lunch, the children napped in their cots with soft music playing in the background.

Please note that the diaper changing station (changing mat) is too close to the snack/ lunch table. The tables or the changing mat should be relocated to a different part of the center.
