- -Each child needs to have an easily accessible space to store their personal belongings, which is labeled with their name and used only for the intended child. Once each child has a designated space to store their belongings a picture will be sent to licensing staff
- -Posted in a visible and prominent place in the facility are the following documents: The license, inspection report, orders for compliance, daily routine, evacuation procedures, name of administrator, name and telephone number of QA Monitor and inspector
- -Operator shares that going outside has been hard lately because children do not have the proper clothing's, parent have been advised to bring warmer clothes.
- -Lunch and snacks are provided at recognized meal periods
