-The child-to-educator ratio					
-Criminal record checks / vulnerable sector checks, valid first aid certificates and valid CPR certificates, as well					
as verification of job descriptions and responsibilities for new staff members					
-Positive guidance. The quality assurance monitor observed an educator sitting with a small group of children at					
a table, discussing the difference between small, medium, and large. In another classroom, an educator gently					
asked a child to come see her and positioned herself at the child's level to invite them to listen to the story. During the quiet/rest period, an educator gently scratched a child's back.					
During the quietrest period, an educator gently scratoried a crillo's back.					
-Daily activities and documentation. In another classroom, preschoolers were observed engaging in					
independent reading (looking at pictures and turning pages). A Christmas wreath made by the children was					
displayed in one classroom. In another classroom, there were gingerbread crafts, posters documenting a					
musical-chairs activity, and photos of the children with Santa Claus accompanied by related documentation.
