The staff member in question left the premises and must obtain a check with Social Development before being permitted to return on site.

Comments: During the visit, the Quality Assurance Monitor observed two associated persons present on-site who do not have their checks with Social Development. Each associated person must complete a check with Social Development. The two associated persons must not interact with the children before obtaining their checks with Social Development. During the visit, the Quality Assurance Monitor observed two associated persons present on-site who do not have their criminal record checks. Each associated person must complete a criminal record check/vulnerable sector check. The two associated persons must not interact with the children before obtaining their criminal record checks.
