General Comments
Licensing staff arrived in the morning just at the end of snack. All food is brought from home. The children were having free play and transitioned to cleaning up their toys and going outside to play. Both the outside and inside areas are well set up for the children's use. There was a variety of inside toys such as blocks, books, stuffed animals etc. and a ball pen, table, chairs, comfortable reading nook, play kitchen etc. the room was clean and bright with calm colours and a carpet. Outside the backyard was fenced and set up with water, a deck, ride on vehicles, a sandbox, mud kitchen and small picnic table and child sized chairs. The Operator rotates the toys inside and outside and she set the children up to colour on the picnic table which they all enjoyed. The Operator is kind and gentle with the children and is teaching them about how to play together and be kind. She has examples of the children's activities in pictures on the wall and also on her childcare Facebook page for the parents to see. She showed me an interesting video of an activity where the children had large pieces of tape set up and they stuck small wooden popsicle sticks to the tape. Their dance play was also fun to watch. Monica will add her new Quality Assurance Montior and Inspector to the parent board which was up to date. All diapering protocols were followed, and the diapering procedures were posted by the diapering table. After lunch everyone prepared for nap and quiet time. The transition was calm and pleasant, and she played appropriate soothing music to help with this transition. She set up the crib, playpen and cots for napping and she supervises the room while they sleep. The Operator will begin her Introduction to the Curriculum in the Fall.
