<p>During renewal inspection children and educators were observed in play and learning together. Children engaged in art, block play, playdough, dramatic play and organized games. Educators were observed speaking kindly to children and engaging at their level.</p> <p>Environments are arranged to invite children's engagement with a variety of materials. The cleanliness of the play spaces demonstrates staff's commitment to ensuring the health and safety of all children in their groups.</p> <p>As discussed, children from full day program cannot move between "bubble" groups daily to take part in preschool/playschool program. As per the Covid-19 recovery guide dated August 17, 2020- groups are to remain the same throughout the day (page 6).</p>
