General Comments A renewal inspection was completed today. Children were observed engaging in inside and outside play and having lunch. Educators in all learning environments were observed down on the floor or sitting at a table engaged with the children in their learning and play. Children's art work is beautifully displayed on the walls and hanging from the ceiling for them to revisit when

they wish.

The children's learning has entailed: Spring, Flowers, Transportation. Webs and documentation supporting the children's learning is posted throughout the learning environments.

Discussions were had with educators regarding allowable materials and the educators were referred to the COVID19 Guidance for Early Learning and Childcare Facilities, December 16, 2020. Educators asked about sand/water and play-dough. Appendix C--Cleaning and Disinfecting, in this document outlines all allowable materials and the cleaning requirements as per the guidelines. Recommending sharing this document with all educators in all programs.

The children were observed happy and content in both their inside and outside environments and with their educators. The educators were observed speaking appropriately and kindly to the children, getting down to their level in their engagements with the children.
