Comments:

Current COVID-19 Recovery Phase Guide is not being used. Staff and Administrator are using the out dated document. It is essential that this information is current, educators are aware of changes and guidelines are implemented in the facility.

Screening:

Inspector was not screened at the door upon arrival for Monitoring Inspection. Administrator was immediately notified and administrator then did the screening.

Updated Screening Questionnaire was not used during screening. Screening Questionnaire (Appendix A of the COVID-19 Recovery Phase Guide) must be used during the screening of visitors.

Review of Screening section of COVID-19 Recovery Phase Guide is needed with all staff. Screening of children is now the parents responsibility before they arrive at child care each day. Parents must fill out Appendix E of the COVID-19 Recovery Phase Guide.

Hand Sanitizer:

Hand sanitizer is not accessible to educators in the Toddler Room, Preschool Room or in the Outdoor Play Area. Hand sanitizer must be easily accessible to educators in each room and in each First Aid bag.

Group Logs:

Group logs are being kept however educators are not using the updated Group Log (Appendix C of the COVID-19 Recovery Phase Guide). Ensure that the dates are correct on each Group Log; Date Group Established is only changed when their is a change within the group(new child attending, new staff, etc). Ensure that Staff confirm Group Log and put the date on the form each day.

Monitoring Inspection - COVID-19 Recovery Phase:

Children engaged in play both indoors and outdoors this morning. Children were engaged in story time, dramatic play and gross motor play. Many positive interactions were observed between educators and children.

Educator from Preschool Room observed helping child with proper hand washing in the washroom. The educator was showing the child how to scrub well and they were singing together. This is great to see!

It is clear that staff are working very hard to keep the learning environments clean and sanitized. One staff was dedicated to cleaning rooms and toys throughout the whole morning. Educators were observed wiping down tables, chairs and outdoor toys.
