QA Monitor discussed with staff adding invitations to the tables for the children to explore when they return from outdoor play and are waiting for lunch to be served.

Handwashing routines observed.

QA Monitor noted some of the fence boards are starting to show some ware. Fence will require some repairs ahead of next Renewal Inspection.
