General Comments

Completed renewal inspection today. COVID-19 screening was completed and signage is posted throughout facility. Hand washing routines of staff and children were observed throughout the inspection. It is evident that there is a cleaning/disinfection schedule in place and that high touch surfaces are being cleaned frequently throughout the day.

The children engaged in indoor and outdoor play throughout the time of inspection today. There is a schedule for outdoor play to ensure that each group of children is able to enjoy outdoor time twice a day without being in contact with another group. This appears to be working very smoothly.

There was evidence of the NB curriculum framework being implemented throughout the facility. Topics of interest were easily identifiable with the rooms and included: construction, volcanos, pets, the human body, winter, and snow. The children were eager to share stories about their experiences and work they have created. Documentation is posted within the rooms to support this in the form of learning stories, webs, creative art, projects, and photographs. Some groups of children have been making predictions about the weather and measurement which has been posted on the walls in the form of a chart. It was great to see documentation posted for the children to review their past experiences. This promotes conversation and literacy and extends opportunities for learning.

General Comments

The educators were engaged with the children at their level and promoted a sense of wonder and curiosity amongst the children. Throughout today's inspection, the children were engaged in solving puzzles, creating with play dough, creating snow sculptures outdoors, reading books, and interacting with their peers and educators while eating lunch.

The outdoor play area is plentiful in outdoor accessories and equipment for the children to explore and the children were observed to enjoy the time they spent outdoors.
