<p><b>General Comments</b></p> <p>Monitoring Inspection:</p> <p>Children and educators observed engaged in a variety of activities this morning including mark making, gross motor play, outdoor play, and stories. The infants were observed exploring gross motor materials on the deck; they climbed, pushed, pulled and slid down the small slide. The twos were observed reading stories and exploring mark making materials at the table. The threes went for a walk to the park to watch the ducks. The preschool group was observed playing a clean-up game with their educator before they went on a walk to the local dollar store to help pick out new art supplies and materials for outdoor play.</p> <p>Purposeful planning is evident through documentation, invitations and materials added to the environments to support the children's current interests (bugs, worms, vehicles, ocean, travelling, flowers, and climbing).</p> <p>Educators were observed conducting headcounts during transition times to ensure all children are present.</p> <p>In response to the recommendation noted at the last Monitoring Inspection, the surfacing has been raked and replenished below the climber and swing.</p> <p>Chicken, rice and broccoli was served for lunch.</p> <p>Handwashing routines were observed after outdoor play, during washroom routines and before mealtimes. Monthly fire drills are documented.</p> <p>Diaper changing procedures were observed to be followed during inspection.</p> <p>Daily attendance records are accurate and reflect all children present. Child-to-staff ratio was observed to be met during Monitoring Inspection.</p> <p>New staff file (3) review was completed; all required documents are in place.</p> <p>Facility is currently meeting the 50% trained Early Childhood Educators (8/9) requirement.</p>
