<p>Comments: While inspecting the outdoor play environment, licensing staff noted a couple of places where the paint is flaking off and could pose to be a safety hazard to the children. There are a couple of boards in the wooded play structure and a couple of boards along the fence that will need to be scrapped and in order to maintain the safety of the children. While licensing staff was still onsite, the operator went outdoors and scraped off the flaking paint.</p> <p>The remainder of the outdoor play environment is very inviting and licensing staff noted an abundance of play materials accessible to the children. Licensing staff also noted a learning story about icicle painting posted on the fence at the child's level for the children to revisit the learning experience.</p> <p>Deficiency is now compliant.</p>			

General Comments
<p>Licensing staff arrived at the licensed facility on March 8th, 2023, to conduct a license renewal inspection.</p> <p>When licensing staff arrived at the facility, the children were just finishing up their morning snack. After snack, the children washed up and got ready to go outside to play.</p> <p>The educators were observed engaging with the children at their level. Licensing staff observed children playing with different centres that were set up for the children upon arriving at the centre.</p> <p>The indoor play environment had a great variety of play materials, and the children were permitted to move freely from one centre to the other. It was also noted an abundance of documentation posted on the walls, at the child's level for the children to revisit the learning experiences.</p> <p>The centre was very clean, and the children and staff files were very organized and complete.</p> <p>Licensing staff is recommending the centre for licensing.</p>
