<p><b>General Comments</b></p> <p>A Monitoring Inspection occurred in the afternoon of December 5, 2025</p> <p>The children were observed in the indoor environment.</p> <p>Upon arrival, the school-age children were finishing their lunch. After lunch, they transitioned to free play activities, which included playing cards, reading books, engaging in the dramatic play area, building with Lego, playing a large-sized Tetris game, and playing a game of cornhole alongside their educator.</p> <p>Seven children then transitioned to the games room with an educator. The children were observed engaging in various activities, including drawing, building with flex bars and connector balls, drawing on the chalkboard, and playing with action figures.</p> <p>The educators indicated that the children are currently interested in sports, dramatic play, and playing board games.</p> <p>Documentation was visible throughout the rooms, including photographs, individual and group artwork, and planning book. The rooms were well-organized and inviting, offering a varied supply of age-appropriate materials, books, and toys.</p> <p>Educators demonstrated positive interactions by using encouraging language and gentle reminders. They asked open-ended questions, listened actively, and extended children's ideas through conversations.</p> <p>A clearly visible and prominent area was designated for posting the facility license, current monitoring reports, and any orders for compliance.
