The children were observed engaged with materials and props in their environment and freely circulating interest centres.</p> <p>There were invitations set up on the tables for the children to explore.</p> <p>There was a variety of dramatic play materials and literacy opportunities noted within the environment.</p> <p>Discussed dramatic play dress up clothes. If these are re-introduced, these should be laundered at least weekly.</p> <p>The children were served apples and crackers for a morning snack today.</p> <p>Hand washing was observed prior to eating snack.</p> <p>There are currently no allergies, and no medications being administered or stored on site.</p> <p>A speech language pathologist from the Talk with Me program has recently visited the preschool.</p> <p>The visitor log is being completed daily.</p> <p>Ensure Appendix 2 consent form from the operator manual is completed for all children's files. Some consents were missing from the files that were randomly selected for review.</p> <p>The fenced in outdoor play area was ice covered today, and outdoor play did not occur. This area will be inspected during a future monitoring inspection.</p>
