Comments:	Educators stated that they had recently thrown out all broken toys and that they were presently awaiting new ones to be added. Toys observed - 1 digger, 6 small toy vehicles, 1 bike. More toys / materials / activities to be added to the outdoor play area. The outdoor play area is to be an extension of the indoor play environment. It is to provide many of the same opportunities, including space for creative, quiet, pretend, and sensory experiences.					

General Comments

A Monitoring Inspection was completed this afternoon.

Upon arrival, the younger group of after schoolers were taking part in a water play activity - emptying a tank of water and preparing the tank for new water toys. The older group of afterschool children were observed entering the center and washing their hands. Children were observed eating their snacks, sitting and conversing with each other, and playing on gym mats. A word web, displaying the word "Family" was observed on the chalk board. The web wasn't completed, but several words and phrases describing families were observed. QAM discussed with educator some ideas on how they could add on to this web. Photos of the children taking part in play, were also observed. A discussion was had with administrator and educator regarding the lack of materials and activities that were available and ready, for the school aged children. The preschool children were dancing to music at QAM's arrival. Children were observed smiling, laughing, and showing off their best dance moves! The preschool classroom had well defined learning centers, and several forms of documentation. A conversation was had with administrator regarding the preschool cozy corner and how an addition of a rug and or other seating materials would make this area much cozier. Both the preschool and school aged children were also observed playing outside. The outside play area lacked toys and outside play materials. Educators stated that they had recently threw out all of the broken toys and that they were awaiting new ones to take their place. The big play structure is in the process of being taken down. Children are unable to use this structure, and administrator stated that it would be fully removed in the upcoming weeks.
