Comments: Preschool room upstairs: The metal on the magnets set (with balls and pieces) has become rusty-to be removed/replaced. The Little Tykes large dump truck and bull dozer toys were observed to be unclean today-to be cleaned/sanitized. The cream colored area rug within the block construction area is stained and torn and fraying at one corner-to be replaced. The folding gym mats under the loft area are torn/frayed-to be removed/ replaced. The wooden unit holding dress up clothes is collecting dust/debris-to be cleaned.

<p>Renewal inspection completed today.</p> <p>Screening was completed upon arrival to facility. Group logs are being completed as required. Advised director that temperature checks are no longer required. Staff on site were observed cleaning/sanitizing commonly touched surfaces throughout the morning. Discussed cleaning schedule with director on site.</p> <p>Hand washing routines were observed during today's inspection.</p> <p>Preschool group was observed engaged in various interest centers within their room. Children were observed building/creating, reading stories with their educators, and engaged within the creative art center. Other children were observed playing together within the shopping interest center engaged in conversations and dramatic play.</p> <p>The toddlers were observed to be engaged in sensory exploration (using sand and water) and also took advantage of the mark making opportunities within their environment.</p> <p>Bins and materials are labelled throughout the environments, providing opportunities for communication and literacies.</p> <p>The preschool group was excited to walk to Saint Rose school to use the playground today for outdoor play.</p>
