General Comments

A follow up to the renewal inspection was conducted today. There are still outstanding orders for compliance to be completed.

Discussed with administrator an Epi-Pen in the school-age room. EpiPens are the only medication that can be easily accessible to staff members and are not required to be locked, however they are not accessible to children. Discussed storing the Epi-Pen in the First Aid bag so it is not accessible to the children but the educators will have it readily available during outings as well as inside the learning environment. All staff to know protocols regarding Epi-Pen and where it is stored.

In the Jelly Fish room the current topic of interest is insects/bugs. Children's art, graphs and web are displayed in the learning environment.

The Lady Bug room the current topic of interests is bubbles. Discussed with educators in the room adding pictures of the children engaged in these activities as well documenting the children's experiences with bubbles. A web is displayed on the wall.

Children in both the Lady Bug and Jelly Fish rooms were observed in outside and inside play during inspection visit.
