Monitoring Inspection - COVID-19 Recovery Phase:

Children and educators engaged in a variety of different types of play this morning including outdoor play, gross motor play in the gym, computer activities, games room activities and art.

Children are divided into smaller groups that each have their own home room. The staff are working very hard to ensure groups do not interact with each other. Washrooms, computer room, playground and gym equipment are sanitized between each group.

A cleaning schedule is in place and extra staff have been hired to increase cleaning throughout the facility. It is evident that staff are work diligently to protect the health and safety of the children by frequently sanitizing high touch surfaces and respecting social distancing outside of their group bubble.
