Renewal Inspections completed today.
Children were observed in their indoor play areas as well as outdoors enjoying their end of school celebration.

The indoor environments were set up for children as they arrived with activities and materials neatly displayed on shelves and set up on tables. Photos of children displayed inside and outside their rooms highlight recent

activities and provides a sense of belonging for the children.

Creative art, games, puzzles, blocks, Lego, dramatic play, small manipulatives, and books are available in all indoor play areas.

Observation and Activity sheets that have been introduced outline activities, opportunities and interests of the children. This has supported Educators to reflect and plan activities and materials to offer the children based on interests and favorite activities. The sheet has also provided children the opportunity to have input and build on their interests. As discussed, ensure that up to date planning is posted.

The end of school celebration provided opportunities for groups to engage in a variety of activities in the outdoor play area. Face Painting, bouncy castle, sponge water fights, and games such as Jenga and Connect 4, were available. Children and Educators engaged together in these activities and enjoyed a barbecue.

Ensure all pages of Essential Routine Services and Emergency Plan document are completed for children who have this in place.
