A renewal inspection occurred today.

Children were observed in various areas of play both inside, outside, and in the gym. The classrooms were set up with age-appropriate toys and materials. The educators were observed engaged in meaningful conversations as well as engaging in play with the children.

K1 Room was observed doing a science experiment where they made their own volcanos using food coloring, baking soda and vinegar. The children showed great excitement as each of their volcanos erupted.

Games Room is interested in using their imagination and dramatic play. The children were happy to share with the licensing staff that they had four weddings that morning. The children created a volcano using paper mache and were excited to bring their volcano outside to watch it erupt.

Art Room was observed having a dance party. The children are currently exploring paper mache.

Planetarium Room are currently interested in the ocean and preforming theater shows.

Zoo Room is very much into animals. Administrator shared with licensing staff that the children take pride in their room and helped with the wall decor.

Licensing observed flexible areas in each room that are rich in opportunities for sensory learning, social interaction, language, exploration, manipulation, and representation. They are purposely designed and planned to enhance children's healthy development and learning. Educators accommodate children's emerging interests by making children's contributions and thinking visible through displays, documentation, photos and artwork.
