General Comments
<p>A Monitoring Inspection occurred in the morning of January 6, 2025</p> <p>The children were observed in both the indoor and outdoor environments, including the transition between the two.</p> <p>Two-Year-Old Room – The children were observed getting dressed for outdoors. The educator indicated that the children are currently interested in baby dolls, building with blocks, and taking care of their classroom fish, Rainbow.</p> <p>Two-Three-Year-Old Room – The children were observed getting dressed for outdoors. The educators sang songs and played Snowman Says while waiting until all the children were ready. The educators indicated that the children are currently interested in baby dolls, books, puzzles, and art activities.</p> <p>Preschool Room – The children were observed eating snack, with handwashing occurring beforehand. After snack, they transitioned to circle time and were observed singing songs before moving outdoors. The educator indicated that the children are currently interested in planets and are engaging with the dramatic play area, which is set up as a medical facility.</p> <p>The children were observed outdoors making snow angels, using spoons and metal bowls, making snowballs, and throwing them in the air, going down the slide, and playing on Rock and Roll teeter-totters. Documentation was visible throughout all the rooms, including photographs, learning stories, a "Languages Spoken at Home" wall, and individual portfolios.</p> <p>Educators demonstrated positive interactions by using encouraging language and gentle reminders. They asked open ended questions, listened actively, and extended children's ideas through conversations.</p> <p>A clearly visible and prominent area was designated for posting the facility license, current monitoring reports, and any orders for compliance. Additional documents observed included incident logs, daily attendance records,</p>

three staff files, and monthly emergency evacuation and fire drills.

A conversation took place with the administrator on the following:
