<p>Children engaged in a variety of activities both indoors and outdoors this morning. Positive interactions between educators and children were observed during play, story time, washroom and hand washing routines.</p> <p>Preschool Room: Discussed with educator documentation of children's interests and how there could be a variety of interests highlighted in the documentation that is posted rather than a weekly/monthly theme. Materials and books can be added to the learning environment based on the children's interests.</p> <p>Book shelf to be added to display books as books are currently in a bin on the floor.</p> <p>Toddler Room: Low open shelving to be added to display and store bigger toys that are currently stored in a bin on the floor.</p>
