General Comments

Monitoring Inspection:

Infant Room:

Educators observed comforting a child who was homesick this morning. Educators observed down at the children's level engaging in play and meaningful conversations.

Discussed with educators creating an inviting and engaging environment for the infants that support their interests. Displaying materials and books on the shelves and tables will invite children to explore the items within their environment. Educator stated the children are currently interested in dumping and babies. What materials can you add to the environment that support these interests?

Today it was observed that the chairs were put away and tables are pushed to the sides. When the chairs are brought out for meal time children begin to climb on them. Discussed the importance of having infant sized tables and chairs out and accessible. Setting up invitations at the tables and chairs throughout the day is an opportunity for children to learn how to use chairs safely.

What items could be added to the environment that will allow the infants to explore climbing safely?

Twos Room:

Educators observed encouraging children while they explored a chair maze they had built. This is a great example of supporting children as they test their limits. How can you document this type of play and learning? Educators have added a variety of materials that support the children's interests in crushing, throwing and dumping to the learning environment. Great additions!

Next steps:

Adding labels and displaying art materials in an inviting way.

Displaying books throughout the room to promote literacy.

Connecting documentation to values of the NB Curriculum Framework.

Preschool Groups:

Children engaged in a variety of activities this morning including fossil digging, rocket ship building, stories, hunting for dinosaur eggs and building with blocks. Materials have been added to the environments to support the children's interests in dinosaurs and spaces. Sensory items have also been added throughout the play area for children to explore.

Discussed the importance of having art materials displayed in open bins rather than closed bins as this makes art materials more accessible for the children.

Next Steps:

Displaying books throughout the room to promote literacy.

Connecting documentation to values of the NB Curriculum Framework.

Hand washing routines were observed today.

A healthy lunch was served - turkey casserole.
