Comments: During inspection it was observed the gate to the preschool outside play area was left open when children were inside playing. Discussed with educators in fenced in area and gate was closed.			

General Comments

A renewal inspection was conducted on this license.

The children were observed during inside free play, outside play, lunch and quiet/nap time.

The 2's (Rubber Ducky Room) have been temporary relocated due to water damage on an exterior wall that required to be repaired. The Director indicated, at time of inspection, that the children should be back in their room by October 6, 2022.
