Monitoring Inspection to follow up on orders for compliance ahead of Renewal Inspection. All orders are now compliant.
Children and educators were observed engaged in a variety of outdoor play activities this morning including sand play, riding on toy vehicles, climbing, jumping and exploring the outdoor play materials. A small group of children were observed relaxing on a blanket in the gazebo.
The indoor environments are set-up with a variety of materials for the children to explore freely. New baskets with laminated labels have been added throughout each environment. A gross motor area has been

implemented within the preschool indoor play area to encourage big body movements indoors. All shelving has been decluttered and organized since last inspection.

Purposeful planning is evident through documentation (learning stories, children's words, art pieces and photos) that is displayed throughout each learning environment.
