## **General Comments**

The renewal inspection was completed this morning. The children were observed freely circulating interest centers. The educators were observed interacting with the children at their level and engaged in conversations. Handwashing occurred upon a child's arrival and prior to eating snack.

The children have had a week with "special days" leading up to March break. Today is beach day. The room has been set up with tropical decorations, a beach volleyball net, and accessories have been added to the environment.

A variety of creative art materials were set up on the table for the children to explore.

The children had a picnic snack today sitting on their towels that they had brought from home.

Portfolios for each child are positioned on a low shelf for children to review as they wish.

More open ended art opportunities to be provided, less pre planned crafts.

There are no anaphylactic allergies at this time. Sensitivities are posted on the board within the indoor play area.

The children typically play outdoors toward the end of the morning. They did not participate in outdoor play today, as the temperature was very cold.

Recommending that the educators focus on more open ended art opportunities. A resource will be sent to the staff to support this.
