<p><b>General Comments</b></p> <p>A Monitoring Inspection occurred on May 28, 2025.</p> <p>Children were observed engaging in both outdoor and indoor free play. Proper handwashing procedures were followed during the transition from outdoors to indoors. Steps and platforms were available to help children reach regular-sized toilets and sinks.</p>

General Comments

Educators noted that the children are currently very interested in the outdoor mud kitchen, where they use natural materials to create imaginative food items. They are also exploring bee habitats through art and sensory experiences and enjoying active play outside with group games such as tag. Additional opportunities for literacy and numeracy exploration were available through a chalkboard wall and tree stumps. Educators were actively engaged with children during outdoor play, supporting and extending their learning. A visual web of examples linking the program to the New Brunswick Curriculum Framework was displayed on the wall for parents and visitors.

The facility maintains a daily incident log and conducts monthly emergency evacuation drills. The daily routine is clearly posted, and evacuation procedures are displayed prominently. Parents and children are greeted warmly upon arrival, contributing to a welcoming atmosphere. The room is thoughtfully arranged and inviting, with materials intentionally set up to spark children's interest and engagement.

The environment included a wide range of age-appropriate equipment, books, toys, and materials. A sensory area was available, with sand, water, and a variety of accessories provided in sufficient quantities and rotated regularly. Traffic areas and outdoor walkways were clean and free of clutter. Toxic products such as cleaners were locked and inaccessible to children. Drinking water was available throughout the day.
