Monitoring Inspection - PD Day:

Room #5 is the only one operating on this license this afternoon due to low attendance for the PD Day. The other environments were observed by QA Monitor; however, children were not present.

Children and educators observed during transition to outdoor play this afternoon. Staff were observed taking small groups out as they were ready in their winter clothing to avoid long wait times. Educators were observed offering children choices and redirecting their behaviors. Children were observed engaging in outdoor play in the snow this afternoon.

QA Monitor noted that recommendations from last Monitoring Inspection have been implemented regarding documentation. Documentation is displayed throughout each environment that supports the children's current interests (pop music, vehicles, and Christmas). Open ended art pieces and photos of the children are displayed.

Cereal was served for snack this afternoon.

Handwashing routines were observed during washroom routines.

Monthly fire drills are documented.
