Examples of items to add, but not limited to: costumes, hats, scarves, purses, office supplies, restaurant items, clipboards, cash register, money, pretend food, real life items, dolls, loose parts, tools, items that support the children's interests. Previous comply by date July 12, 2021.</p> <p>Senior Group: Art materials depleted. Scissors, glue, paint, paint brushes and white paper insufficient quantity accessible for the children present.</p>

<p>Comments: Senior room: Clear storage bins throughout room broken. Broken bins must be replaced promptly.</p> <p>Junior room: Dramatic play materials unorganized in a large bin on the floor. Hooks and shelving to be added to create a dramatic play area that is inviting.</p>			

General Comments
<p>Monitoring Inspection:</p> <p>Followed up on flood in Mini Gym. Roof leak appears to be repaired. Ceiling has been repaired and painted. The mini gym was not set up today; as it was stated that the new shelving units have not arrived yet. Discussed ways to set up this area to ensure children have an environment of their own. Tables and benches can be used until the replacement shelving arrives.</p> <p>All children were greeted in a way that is welcoming upon arrival to the program this afternoon. Children appear to be excited to see the staff when they arrive.</p> <p>Junior Room: Children arrived from school to an environment that was set up with invitations and materials that are engaging. A group of children were engaged in creating open ended art pieces with the variety of art materials accessible to them. The educator observed engaging in conversations with the children at the Lego table.</p> <p>Senior Room: Children engaged in board games with their educator and peers. A small group of children were relaxing in the cozy area with a book. Positive interactions between educators and children were observed during snack time.</p> <p>Next steps: Adding documentation that supports the children's interests and learning. Adding loose parts to the environments. Displaying challenges, questions and art pieces.</p> <p>Hand washing routines were observed.</p> <p>Through discussions with staff today it was determined that the facility is currently having some struggles with people vandalizing the playground area after hours. Recommend putting a daily checklist in place to ensure staff have checked the playground for hazards before children arrive to outdoor play area.</p>
