Comments: One group had more children recorded in attendance than were present, these children had joined another group in the facility. The children were not recorded on the attendance records of the room that they had joined. Attendance records are to be completed each time a child arrives and leaves, they must be accurate and reflect all children present at any given time. If children are moved between groups, they must be signed out on the attendance records for the group that they leave, and signed in on the records for the group that they join.

Comments: Educator did not check the washroom before the children went in. As there are staff from other organizations in the building, educators must visually check that the washroom is clear before permitting children inside. Administrator to review this requirement with all staff.								
General Com	ments							
Supervision - it was observed during the inspection that a staff member, who is under the age of 18, was escorting a child into the building from the outdoor play area. As this staff member is under 18 they must be supervised by a staff member who is 19 or older. Administrator stated that the supervising staff outside would communicate with the staff inside to "supervise" this staff person when they escort children inside to washroom or classroom, however no staff entered hallway or were otherwise observed supervising this staff. An educator under 18 is unable to obtain the CRC and VSC therefore they are not to be alone with children.
