While on site, QA monitor observed two year old children in the infant room. Administrator advised QAM that there is a plan in progress to transitioned them into the 2 year old class in September. Operator must send a written plan to QA monitor as soon as possible, so this can be documented.

While on site QA Monitor was able to observe indoor free play and snack time. Positive interaction between educators and children were observed.
