Comments: Areas of the fence are in disrepair, sharp edges of wire and gaps that pose a hazard. Fence must be repaired. There are plastic cutting boards placed under the legs of the swing set side of the structure and the structure lifts off the ground when the children use the swings. The climbing wall lifts off the ground when you pull on the climbing rope, the legs at the monkey bar end of the structure lift off the ground. There is a rope and tape fastened between two pieces of the play structure. This play structure does not appear to be safe, children cannot use the structure until it is safe.

Comments: There are no play materials present in the outdoor play area. This area must be provisioned with a variety of play materials in a sufficient quantity for the number of children who use the space. All elements that are available for indoor play can also be used outdoors. Some suggestions are trucks, cars, blocks, kitchen center or other dramatic play area and accessories, skipping ropes, hula hoops, outdoor games, elements of natural play such as a sandbox & water table and accessories. General Comments

The manufacturer's instructions were not available onsite for the new play structure, Administrator was not able to verify if the structure was installed in accordance with manufacturer's instructions. Play structure not to be used until Operator can confirm that it has been installed in accordance with manufacturer's instructions and is safe. Operator will collect a copy of the manufacturer's instructions and contact the QA Monitor with further information on the safety of the structure and QA Monitor will conduct a follow up inspection to confirm.
