Comments: During the renewal inspection, the inspector was not able to obtain proof that all educators have completed their professional learning hours. The operator must ensure that all educators complete 10 hours of professional learning hours and a copy of their certificates must be at the facility.			
21 The daily activities of a licensed facility shall be purposely planned in advance and documented and shall respond to the capabilities, needs and interests of each child.	21	Nov 17, 2023	
Comments: During the renewal inspection, the inspector observed in 2 different classrooms that the programming is not documented daily. The operator must ensure that the facility implements an inclusive daily programming which contains a variety of purposely planned activities, opportunities and experiences.			
24(1) For the purposes of subsection 20(1) of the Act, the following records and documents shall be maintained on the premises of a licensed facility: (b) child records that include: (ii) the name, address and telephone number of the child's medical practitioner.	24(1)(b)(ii)	Nov 10, 2023	
Comments: During the renewal inspection, the inspector observed that 1 out of 12 audited children file is missing the name, address and phone number of the medical practitioner. The operator must ensure that all children's file are completed with all the information as prescribed in the regulation.			
24(1) For the purposes of subsection 20(1) of the Act, the following records and documents shall be maintained on the premises of a licensed facility: (b) child records that include: (iv) the name, address and telephone number of at least two individuals authorized by the child's parent or guardian to pick up the child and to be contacted in case of an emergency if the parent or guardian cannot be reached,	24(1)(b)(iv)	Nov 10, 2023	
Comments: During the renewal inspection, the inspector observed that 1 out of 12 audited children file is missing an emergency contact. The inspector also observed that 1 emergency contact is missing the full address and phone number. The operator must ensure that the name, address and phone number of at least two individuals authorized by the child's parent to pick up the child and to be contacted in case of an emergency is documented in the child's file.

Comments: During the renewal inspection, the inspector observed 4 cans of shaving cream (Gillette) in 2 different classrooms in an unlocked cabinet. The educators immediately locked all cans of shaving cream in a lock cabinet. The inspector also observed a gallon of paint in an unlocked cabinet. The administrator immediately placed the gallon of paint in a locked storage area. Deficiency is now compliant.			
40(1) An operator of a licensed facility shall ensure that personal belongings of a child receiving services at the licensed facility that are brought to the licensed facility, including combs, brushes, toothbrushes, towels, washcloths, bedding, pacifiers and soothers, are (a) labelled with the name of the child.	40(1)(a)	Nov 13, 2023	
Comments: During the renewal inspection, the inspector observed that 2 out of 4 water bottles are not labelled with the name of the child. The operator must ensure that all personal belongings brought from home are labelled with the child's name in order to prevent and control communicable diseases.			
41(3) An operator of a licensed facility shall (a) post diaper-changing procedures in diaper-changing areas.	41(3)(a)	Nov 07, 2023	Nov 07, 2023
Comments: During the renewal inspection, the inspector observed in 1 classroom that the diaper changing procedures are not posted in the diaper changing area. The administrator posted a copy of the diaper changing procedures in the diaper changing area. Deficiency is now compliant.
