<p>Licensing staff was screened for Covid-19 upon arrival. Licensing staff was required to show her proof of vaccination along with a New Brunswick issued identification before entering the licensed facility.</p> <p>Licensing staff noted evidence of learning in a majority of the classrooms.</p> <p>The educators in each room was observed using positive child guidance techniques during the licensing inspection visit.</p> <p>During the licensing inspection, licensing staff noted invitations of play for the children in each classroom.</p> <p>Each classroom was observed in outdoor play despite their assigned playground was undergoing construction on the day of the licensing inspection visit. The children were observed playing with the newly fallen leaves and running in and out of the trees.</p>
