Please fill up the crayon bin, the glue bin, water colour paint bin, cotton ball bin and add some paper for the children to mark on. Also, the pencil crayons need to be sharpened.			

<p>General Comments</p> <p>Licensing staff arrived at the licensed facility to conduct the yearly license renewal inspection.</p> <p>Observations made in classrooms during the license renewal inspection:</p> <ul style="list-style-type: none"> -Centres set up with invitations of play. -children could move freely and incorporate materials from one centre to another; -flexible daily schedule posted on the communication board inside each classroom; -learning stories posted on the walls inside each classroom so the children can revisit the learning experiences;

General Comments

-the indoor learning environments were very clean and inviting;
-educators were engaged with the children while licensing staff was observing in each classroom;
-educators allowed time for the children to work out any small disputes between children and stepped in to guide children positively when needed;
-licensing staff observed distinct centres set up in the indoor learning environment. The centres observed were cozy/books, dramatic play with accessories, building, gross motor play, and mark making centres.

Board of Directors names and contact information along with previous inspection reports were posted in a prominent and visible place for parents to see.

Child-to-staff ratios were in compliance according to the Early Childhood Services Act.
