<p>General Comments</p> <p>On the afternoon of my monitoring visit, the Afterschool Program was running smoothly.</p> <p>When I arrived at the door, the educator brought all children to the door to greet me, ensuring that no children were left unsupervised in the room.</p> <p>Children were playing in various areas of the room and moving freely between different choices. I observed children building with blocks, coloring at the table and in the play tent and listening to music. This group really enjoys coloring and listening to music and the educator was engaged with the children singing along and coloring with them.</p> <p>The educator uses good child guidance practices and speaks to the children in a respectful and understanding way. I observed her using lots of patience and getting down to the children's level. She has a strong rapport with the children.</p> <p>Children had time warnings between transitions and activities.</p> <p>I observed new art work posted that the children created and a large Spring Weather chart that the children are documenting the weather as a countdown to Summer!</p> <p>I checked the Fire Drill record and it is now up to date with drills being conducted and recorded each month.</p>
