## **General Comments**

Upon licensing staff's arrival, there was one child in attendance for the morning preschool program. This program runs out of the EXP Room. The room was prepared for the day with tables set up with invitations-playdough, coloring and play food with a written prompt. The educator followed the child's lead and remained engaged with her during the inspection. They played Barbies and Little People together on the carpet. The educator spoke kindly to the child and asked questions to get to know her since this is a new program that has been running for a few weeks and staff are still getting to know the children.

The room was clean, organized and had children's art posted. There were mini flowerpots that were painted by the children in the window and seedlings are growing. The room is also used as an afterschool room. The afterschool educator has been working on improving this space and the room looks inviting and is set up in a child-centered way with age-appropriate books and materials.

The Jones Room has also seen improvements in looking more child-centered with art posted, recent photos of the children, a large variety of quality children's books and organized materials.

The transition from the afterschoolers arriving to washing hands and eating lunch was smooth and children were familiar with the routine. There was ample time to eat, and children could begin playing when they were ready while others could finish their lunch.

The educators in both rooms displayed kindness towards the children and were engaged and attentive. Gentle reminders were provided to sit at the table while eating and to make safe choices with toys. Time warnings were used to remind children that it was almost time to clean up and get dressed to go outdoors.

## **General Comments**

Licensing staff observed no materials in the outdoor play space today for the children to play with. The children were playing on the large play structure but the sandbox and pavement on the basketball court had no materials for those areas. Suggestions are skipping ropes, balls in sufficient quantity, chalk, buckets, shovels. Items from the classroom could also be brought out- books, materials for coloring, card games. With no outdoor storage available for this playground, educators have to transport the materials to the space. A utility wagon would be a good method to bring out a variety of materials and at the guantity required for the children.

Due to the preschool program running for 6 weeks, an educator with an ECE was not found in time for hire. If the program is going to run in the Fall of 2023, then an educator with their ECE must be hired.
