## General Comments

When I arrived all the classrooms were getting ready to go outside. The children played outside until 11 am. When they came in from outside, they played with some toys and read some books before lunch was served at 11:30. After lunch, the children had a nap/quiet time.

Many of the classrooms were newly painted and reorganized. The lighter more neutral colors make the rooms appear brighter and allow the children's arts and crafts projects to stand out more. All the other learning materials on the wall are also more visible.

The staff is polite and respectful towards the children. Lots of positive child guidance observed such has gentle reminders, encouragements, and celebration of achievements. The staff were attentive and engaged with the children.

We would ask that all mop and mop buckets be removed from the bathrooms and classrooms because they contain bacteria and should not be at reach of children. They should be stored in a closet or utility room.

There is what appears to be black mold growing on the window in the upstairs bathroom. I would ask that this be inspected, and the mold removed.

In the infant room in the basement, there is a roll of wallpaper hanging on top of the curtain rode. I would ask that this be removed as it could fall on a child.
