<p>General Comments</p> <p>Monitoring visit performed today. I attempted a visit during March Break, but the group had gone on a fieldtrip. Upon arrival, children were having bathroom breaks and getting ready for outdoor play opportunities. The plan today is to go for a walk to moss island(children named it). While waiting for one more friend to arrive the educators walked the children to the side hill to play before leaving for their walk. Educators were observed supervising toileting and assisting with dressing and making sure children collected their water bottles for the walk. Lots of conversation and positive interaction observed between staff and children.</p> <p>Outdoor play area is being maintained. The pergola's are great addition as they provide some much protection from the sun.</p> <p>Administrative records were reviewed - children's attendance was reviewed, staff attendance, fire drills performed (good timing) and outdoor check list including new staff info. Please read comment above.</p> <p>Centre is always very organized and inviting. Children are involved in Earth Day activities. Preschool children are also preparing seedlings for planting and making clay creations. School age children are also involved in a variety of activities and growing sunflowers. The school age children also have a recycling program ongoing and are interested in composting. I would recommend contacting PH for some suggestions and ideas.</p> <p>The 2 chairs in the school age room need recovered or replaced as the finish has become worn and difficult to clean and sanitize. Please address by next visit. The other observation are the tires in the outdoor play area - poking holes in the sides will help them drain. With spring season upon us, will be an attraction for mosquitos and black flies.</p>
