General Comments

Licensing staff arrived in the morning to conduct a monitoring visit. The children were just finished snack and hand washing and preparing to play outside. The outside play area has a fenced in portion and a huge field that has been transformed into an outdoor classroom. The fenced in area features 3 pergolas for shade with vines and grapes growing on one, a covered section with a couch and rug for reading and cozy activities, wooden playhouse, wood stump chairs and planters filled with herbs, nasturtiums, marigolds and scarlet running beans to name a few. There is pea gravel surfacing and a large climber with a slide.

The larger outdoor larger space it is equally inviting and engaging. The operator has created a large circular track with crushed rock that the children can ride their tricycles on, hammocks, a wooden pirate ship, a sand hill, mud kitchen, small building with mark making materials, tables and books and a bathroom. There is a wooden teepee, a small hill to climb, a swing, tires for climbing, a dome with extra mulch surfacing, picnic tables, a storage shed and an abundance of loose parts and shovels etc. to support the play. In the very back is a walking trail and in the middle section a garden and a small tree-ed area with a huge rock and lots of rocks on the rock and little paths through the trees. All designed to support the NB Curriculum and the environment as the third teacher. The outdoor play area supports co-created play, imagination and engagement and the children played all morning without becoming bored and with good natured cooperation.

When the children came in for lunch, they washed hands and their teachers' read stories to them while they ate and prepared for quiet time. The classrooms are inviting and invitations for learning are set up everywhere. The two-year-old classroom has a beautiful reading corner with the Very Hungry Caterpillar learning story poste and a tree with fairy lights and a wall titled Look at Our Families filled with family pictures. The daily schedules are posted pictures of the activities and words and labelled baskets with loose parts. There are live and fake plants in each room, fairy lights and painting boards, felt boards, lots of loose parts and playhouses and child sized furniture. The three-year-old room has a great corner for building and block construction and an interesting globe of the world. The 4-year-old room has a leg wall with constructions already started. They have a nice reading corner with cushions that look like pieces of wood. The afterschool room is bright and airy with tables for eating and play with lego and board games etc.

General Comments

The facility is clean, bright and welcoming with staff pictures and biographies posted in the entryway next to the parent board. Child guidance is kind and pro-active, supervision was excellent and the staff were very engaged with the children and attentive to their needs. All transitions were smooth and peaceful and the transition to rest time was calm and pleasant.
