General Comments

Licensing staff was thoroughly screened for Covid-19 upon arrival at the centre.

The four year old classroom were getting ready to go for a walk to O'dell park when licensing staff began observing in this room. Licensing staff accompanied the four year old class to O'dell park. While at O'dell Park the children and educator engaged in a variety of different play activities. The children played on the exposed roots and pretended that he ground was lava and the only safe space was the exposed roots. All ten children engaged in this activity! The children laughed and giggled and really enjoyed participating in this very rich outdoor play.

The three year old class was having lunch when licensing staff arrived back to the centre after going to O'Dell with the four year old classroom. After lunch, the children went directly to the reading centre to explore books and have some quiet play activities.

After nap time, the two and three year old children prepared to go outside for outdoor play. While outside, the children engaged in a variety of activities. Some children played on toy cars and motorcycles while other children climbed on the slide (stationary equipment). Another group of children played underneath the "dome." The dome was covered by a parachute to prevent the two and three year old children from climbing it. While underneath the "dome" the children pretended to have a bonfire and roast hotdogs and marshmallows. Again, another example of very rich outdoor play. The outdoor environment was set up for the children to explore and was child led based on the children's interests.

While observing in the afterschool room, licensing staff observed the children and educator engaging in telling silly stories and heard a lot of laughing. The afterschool group went outside for outdoor play at the end of the day after the preschool children went back inside.

The educators at Victoria Street Adventureland Daycare have a wonderful way with the children. The educators encourage the children to problem solve and engage with the children at the child's level. Licensing staff observed an educator explain to a child why they should not throw a rock on the playground because they may accidentally hit another child. Well done!!
