## **General Comments**

Upon Licensing staff arrival, the children were playing outside. Educators were spread out to maintain a clear line of sight and were actively engaged with the children. Children were observed playing with the mud kitchen making tea and cake with cups and bowls, playing with trucks, on the wooden play climber with two slides, using shovels, building with outdoor wooden blocks and using balls in angled pipes attached to the fence. Educators were observed conducting frequent headcounts, playing with the children at their level, singing songs, offering hugs and encouraging children to use kind words with their friends.

Before lunch, the children came indoors. Personal belongings were hung up and placed in their cubbies. Hand washing was observed for each age group and diaper changing procedures were followed. While waiting for their lunch the children played throughout their space. Each room was organized, tidy, and contained ageappropriate play material. The 2-year-old room had a barn with animals, wooden puzzles and blocks, books, a wooden play kitchen with accessories and dress up clothes. The 3-year-old room had a cozy bench with pillows for stories, bins of loose play pieces, dress up clothes, a chalk board wall and large play kitchen with accessories. The 4-year-old room had wooden blocks, bins of loose play pieces, twinkly lights, a play kitchen, dinosaurs, and books. Children's artwork was on display in each room and there is evidence of lesson planning and learning stories on display.

The transition between lunch and nap time was smooth. There is evidence of a daily routine. Soothing music

was played and children who needed extra cuddles to help fall asleep were held. Children who did not nap went outside to play as the weather today was sunny and nice. Child to staff ratio was maintained at all times and attendance sheets were taken outdoors. Shortly before the younger children woke from their nap, the other children came indoors for quiet time and were observed playing with wooden puzzles, colouring and using foam blocks.

The parent board in the main entry contained all required documentation and was visible. Monthly fire drills are being completed and logged and playground maintenance checks are recorded. Please ensure that EpiPens stored safely out of reach of children but are not in a locked medication box for easy accessibility in case of need.
