| <p>General Comments</p> <p>Licensing Staff arrived at the facility to conduct a Monitoring Inspection. Upon arrival, the Educator was outside waiting for the school bus to arrive. The Educator had attendance records, and a first aid kit outside with them as they waited. Once the bus arrived, the children were greeted and signed into the attendance records. The group went straight to the backyard where some children were observed having afternoon snack. Others were observed accessing various balls and equipment from a large storage bin located under the deck. The bins offered a variety of materials such as soccer balls, basketballs, footballs, pylons and shovels.</p> <p>Later in the afternoon the children were observed playing a game they made up, "Bag Ball". The Educator threw the ball, and the children used handheld nets to try and catch the ball. Children who chose to watch the game were observed cheering on their peers. Throughout the afternoon the children engaged in a variety of active games such as hockey, bag ball, playing "man hunt" and using the outdoor obstacle course. The Educator was engaged with the children in their games.</p> <p>Inside, the facility was clean, organized, and welcoming. The cubby area was tidy, and each child has space for their personal belongings. Pictures of the children with their peers and a birthday wall was observed in the main entrance. The indoor environment had various resources and materials for the children, such as hot wheel cars, a dollhouse with a bin of accessories, crafting materials, mini sticks, foam pucks and hockey nets as well as several books. All play materials were all accessible to children, on low, open shelves. Staff and child profiles were reviewed during today's Monitoring Inspection. The files were organized and contained all required documents. Only positive child guidance was observed today. The Educator engaged in several active games with the children and was heard offering praise and words of encouragement.</p> |
