| <p><b>General Comments</b></p> <p>Licensing staff conducted the renewal inspection. The program was organized to accommodate three school-age groups. Upon arrival, the youngest group was eating snack, consisting of cheese and crackers, while the educator read a book to the children. The oldest group was in the gymnasium participating in a soccer game with the educator and had snack following the activity. The third group returned from outdoor play and transitioned inside for snack, and the educator played a game of "guess the song" with the group as they ate.</p> <p>Following snack, the youngest and oldest groups transitioned outdoors. An educator had prepared a slime-making activity for the children. The ingredients were organized on a table, with an individual cup provided for each child to make their own slime. The educator guided the children through the steps of the activity and provided support and encouragement as they participated.</p> <p>Staff and children's files were reviewed and found to be complete at the time of the inspection. Fire drills are conducted monthly. Only positive child guidance was observed.</p> <p>Licensing staff recommends the program for renewal.</p> |
