9(1) The child-to-staff ratio is one educator for each of the following groups of children of the same age receiving services at a full-time or part-time early learning and childcare centre: (a) three infants or fewer; (b) five children or fewer who are two years of age; (c) eight children or fewer who are three years of age; (d) ten children or fewer who are four

years of age or older, but who are not yet attending school; and (e) 15 school-age children or fewer.

General Comments

The educational requirement for the administrator and educators working with infant and preschool children is met. The previous non-compliance was based on the staff as an entirety which included school age children.

Covid-19 Guidelines are currently being followed. Screening was completed for licensing staff upon arrival. Nap mats are clearly divided and separated with appropriate spacing in between.

Dec 16, 2020

General Comments

A wooden box was constructed to contain the diaper genie where soiled diapers are disposed of.

Upon arrival infants were eating in their high chairs with only 1 teacher supervising 5 infants. Licensing staff asked educator who the second staff was in the room. The educator stated that the educator who is normally in this room, was in the kitchen on break. Licensing staff asked who was covering the educator's break. There was a lot of confusion as to whom was covering. The educator was not aware that a second staff was needed while babies were eating. Another educator arrived and stated that she was the second staff covering however was not in the room as she was making a phone call. Licensing staff advised educators that child / staff ratio must be maintained at all times when children are awake. There were enough staff in the building to cover child / staff ratio at time of visit.

The cylinder in the outdoor play space is still in place. Operator has stated that they cannot cover up this well cap due to accessibility. The cylinder is not secure and can be tipped over leaving the well cap exposed. Licensing staff took pictures to submit to Licensing Manager for recommendation.
