<p><b>General Comments</b></p> <p>There are many materials and learning centres readily available for the children for each age group served. Educators were engaged with children at the time of visit. They engaged in both conversation and play. Educators speak to children in kind and positive manners.</p> <p>Filing system to maintain documents were complete and maintained. Licensing staff was easily able to verify all information needed for licensing purposed. Financial information was not on site; however, administrator stated that they would speak to owner to have a copy forwarded to facility.</p> <p>Licensing staff had a conversation with administrator regarding field trips and the use of wading pools in the city. Administrator was advised that the same regulations apply to wading pools as they do with other pools that facilities use. Administrator advised licensing staff the currently the children are not transported nor do they go to pools.</p>
