General Comments

Monitoring visit performed. no deficiencies observed during my visit.

A few staff records were reviewed during this visit. No new staff observed.

Upon arrival, licensing staff met with the Administrator and then proceeded to the outdoor play area. The babies and educators had gone for a walk around the neighbourhood and the 4's were at the gym on campus with their educators. The 2 and 3's were outdoors exploring and enjoying a variety of activities.

There were lots of toys, equipment and materials for children to explore their environment - a huge sandbox with oodles of implements, a climber, lots of ride on toys, tricycles and small bicycles, a mud kitchen with a bin of implements, tractors and excavator etc,

Children were observed engaged in play in small groups and a few children were observed using plastic blocks to build with in the sand box and making impressions with the implements. There was children's music playing in the background. Educators were involved with children's play. They were observed engaged with children - playing ball, helping children climb the ladder to slide, assisting children on the teeter totter etc. All staff were seen interacting with children.

Licensing staff also observed Educators using positive remarks and playful talk. When assisting children with taking off outdoor gear, educators were heard saying "pull these things, yeah hi 5, hats off, good job, thanks for the hug'. Transitions were also made fun- 'okay, everyone follow me and lets rock and roll' as children mimicked and danced behind their teacher back to the classroom for lunch and nap.

All children nap, though no one is forced to nap. A cart of activities are available for children who do not nap. Children are familiar with the routine and after eating, they older preschool age children were observed setting up their cot with their blankets etc and looking for a book to take to their cot. All children were observed eating lunch and going down for nap, though even the 4's educator remarked that after a morning playing at the gym, she expects all children will nap.

Webbing was observed and October programming posted about the Apple Picking fieldtrip which was also connected to curriculum framework goals.

Lots of educators on site today to cover ratios. NBCC and Highschool Coop students were on site completing their practicums this AM.

School age children arrived during my visit, due to no school in PM. They were having lunch and then going to the gym on campus for the afternoon.

Todays menu - ham, macaroni and cheese, corn, peaches, milk. The menu is also modified for infant and
